Provide an Australian police certificate (AFP) if you have spent a total of 12 months or more in Australia in the last 10 years since you turned 16. Only complete disclosure National Police Certificates issued by the Australian Federal Police is accept. Standard disclosure certificates or national police certificates issued by Australian state or territory police will not be Acceptable. For immigration purposes, Australian police certificates are valid for 12 months from the date of issue.

For every dependant 18 years old or younger who are applying with you, provide: - Copies of birth certificates or the family book showing the names of both parents of all your dependent children - copies of the adoption paper, if applicable.

You should provide with your application any documents or evidence that you think will support your claims for protection.



### Relationship Document

#### > Relationship to the child documents





You will need to give DHA: • birth certificate • marriage certificates • death certificates • adoption certificates • family status certificates or family books if officially issued and maintained If you are a step-parent, you must provide documents to show all of the following: • you were the partner of the child's parent • you have legal parental responsibility for the child • the child's biological or adoptive parentage • that the child is younger than 18 years of age

### Visa Application Forms

#### > Parental Consent Form [Form 1229]

Recommend
Original



If you have a child under the age of 18 included in the visa application and one or both parents (or legal guardians) are not applying for an Australian visa, both parents will need to complete and sign the Form 1229 - Consent form to grant an Australian visa to a child under the age of 18 years. If you have sole custody of the child/ren, provide evidence such as a court order.

#### > Undertaking declaration [Form 1257]

Recommend



If the applicant is not staying with a relative or legal guardian, provide Form 1257 Undertaking declaration. The person they are staying with must sign the form.



#### **Australian Passport OR Permanent Residency Grant** Letter

Provide proof of your eligibility to propose the applicant, such as: • Australian birth certificate • certificate of Australian citizenship • evidence that you are a permanent resident in Australia, or • evidence that you are an eligible New Zealand citizen If you are proposing as an organisation, provide: • names of office holders • a statement of the organisation's objectives, activities and funding
