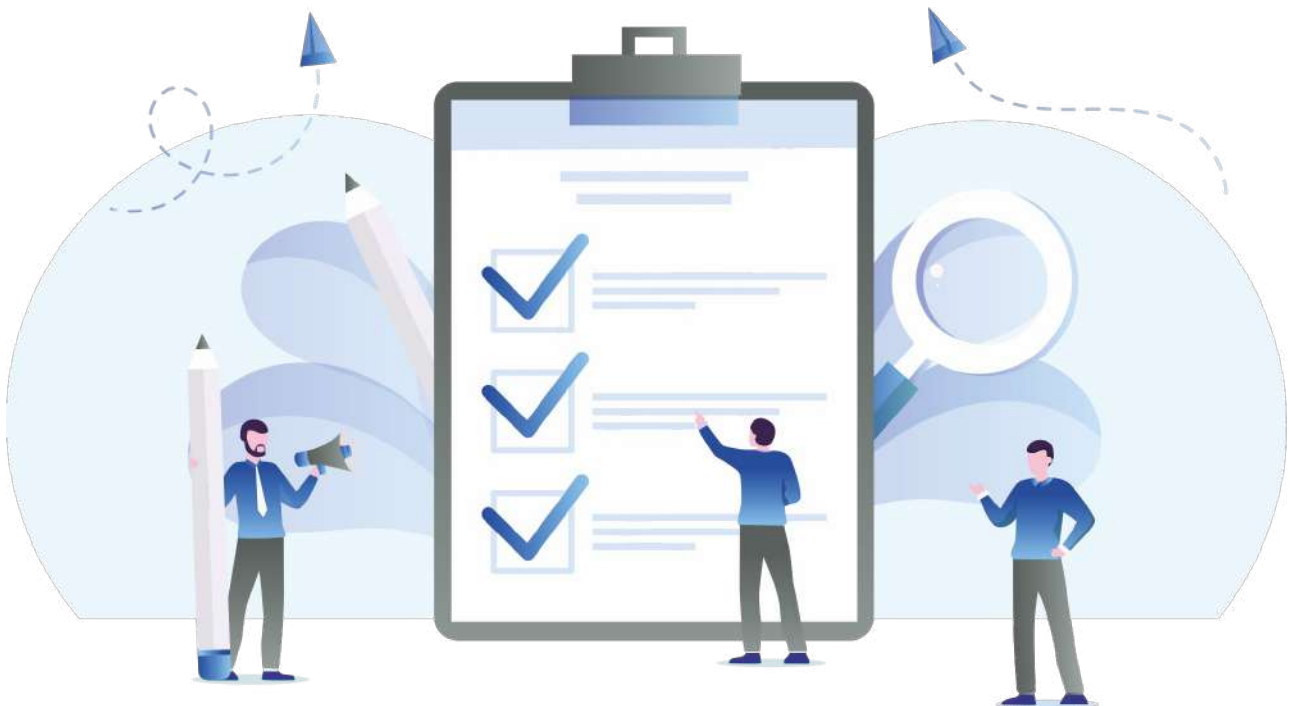

> Passport

> National Identity Document

All applicants must provide a valid and current National Identity Card.

🕒 Evidence of Change of Name

> Marriage Certificate or Deed Poll Certificate (Proof of change of name)

👍 Recommend 📄 Original

If anyone in the application has changed his or her name, certified copies of documents verifying the name change. This might include a marriage or deed poll certificate or a certified copy of evidence of the name change.

🕒 Other Documents

> Birth Certificate or Adoption Letter (if applicable)

> Balance of family documents

Character Documents

> Australian Federal Police Check

Provide an Australian police certificate (AFP) if you have spent a total of 12 months or more in Australia in the last 10 years since you turned 16. Only complete disclosure National Police Certificates issued by the Australian Federal Police is accept. Standard disclosure certificates or national police certificates issued by Australian state or territory police will not be Acceptable. For immigration purposes, Australian police certificates are valid for 12 months from the date of issue.

> Overseas Police Clearance Certificate

SPONSOR APPLICANT

🕒 Visa Application Forms

> **Sponsorship for migration to Australia [Form 40]**  Required  Original

Complete Form 40 Sponsorship for migration to Australia.

🕒 Other Documents

> **Relationship to the Sponsor**  Required  Original

To prove your relationship to the applicant, provide: - Birth certificate - Marriage certificates - Death certificates - Adoption certificates - Family status certificates or family books if officially issued and maintained

> **Residential Proofs**  Required  Original

Evidence of Residential proofs includes: - Utility Bills - Bank Statement - Driver Licence

🕒 Applicant's Personal Details



Australian Passport OR Permanent Residency Grant Letter

Required Original

Provide Australian Passport or Citizenship Certificate(if available) or else provide Permanent Residency Grant Letter

Financial Documents

> Eligible community organisation

Recommend Original

If your community organisation is sponsoring the applicant, provide: - your certificate of registration - proof your representative can act for the organisation, such as authorisation from the board or management committee - proof you can financially support the applicant after they arrive in Australia - proof the organisation is lawfully established in Australia and has been actively operating in Australia for a period of at least a year - proof of your organisation's relationship with the applicant's child

> Assurance of Support

Required Original

Provide with an assurance of support when DHA asks for it.

> Superannuation or Taxation Records

Required Original

Provide Superannuation records or (Australian) Taxation records of the last 3 years.
