Original In order to claim an extra 5 Points for Accounting and Engineering stream, the Approved Professional Year Program must be completed within 48 months immediately before the application is lodged with the Department of Home Affairs. Moreover, The professional Year Program must be either related to the

applicant's Nominated Skilled Occupation or a Closely Related Skilled Occupation.

English Language Ability Test

Evidence of Suitable Skill Assessment

> Skill Assessment Outcome Letter

Required Original

You should have a suitable skills assessment at the time of invitation. - Provide a copy of this skills assessment with your application. - For medical and legal practitioners, the following as proof of a skills assessment is acceptable: 1) full or unconditional or general medical registration with the Australian Health Practitioner Regulation Agency 2) Conditional specialist registration with the Australian Health Practitioner Regulation Agency. This only allows you to practise in your speciality. You need no further training or supervision 3) Admission to practice law in the relevant state or territory - Skill assessment must have been obtained in the 3 years before the date of your invitation. If the assessment was for a shorter period, that period must not have passed.



Submit scanned copy of (all) your original qualification certificate(s), i.e. Diploma, Bachelors, Masters or PhD Award certificate.



> Academic Transcript(s)

Submit scanned copies of the official academic transcripts. All the transcripts must be issued by the conferring institution or authority. Definition: An academic transcript is a list of all the units completed for the qualification, including the weighting of each unit (in credit points and/or contact hours) and the marks obtained by the applicant.

> Letter of completion

Please arrange a letter of completion from your institution confirming that you have completed and passed all the requirements for the course and you are eligible to be qualified.

> Evidence of Registration

If your occupation requires registration, submit the evidence of registration with an authorised body. You can provide certified copies of your licence to practice or registration certificate or registration number. Also provide the information about the facilities (if they exist) to verify the registration online.

Barristers and Solicitors: Proof of admission to practice as a lawyer in the relevant state or territory. You must be admitted to practice at the time we invite you to apply.

> Employment references



Submit the copies of the employment reference letter from your employer containing following details: - The position title within the organisation - Duration of employment (start and end dates) - Nature of employment (full time/part time and the number of hours completed per week) - A bullet point list of duties or an accompanying duty statement. Note: Reference letter must be on the organisation letter head and signed by the team leader, manager or employer. It must include contact details and qualifications of the referee.



> Position description (Job Description) Required Original Submit a certified copy of your job description on the organisational letter head. This letter must include all the key roles and responsibilities and tasks for the position held. Note: Submit separate job description letters for each position that you have held (at the same organisation). > Employment contract Required Original Submit the certified copy(ies) of your employment contract(s). Also include all the letter of appointments and promotions along with the contracts while working in the same company. **Payslips** Required Original Submit the certified copy(ies) of your payslip(s). > Tax Documents Required Original Submit a certified copy of your taxation documents as a proof of income from your employment. > Bank Statements Required Original Provide a copy of your bank statements as a proof of income from your employer as a salary or payment for your work (as a freelancer). > Organisational Structure Recommend Original Provide a copy of organisational structure for relevant managerial positions. **SECONDARY APPLICANT** Applicant's Personal Details





Dependents under 18 years of age

> Parental responsibility documents

Required Original



All the applicants under 18 years of age must have a consent to migration to Australia from anyone who has a legal right to decide where the child lives AND is not coming to Australia with the child. Consent can be given by: Form 1229 Consent form to grant an Australian visa to a child under the age of 18 years (168KB PDF) OR a statutory declaration giving their consent for the child to visit Australia on this visa Alternatively, you can provide an Australian court order that allows your child to migrate to Australia, OR that the laws of your home country allow them to migrate Include an identity document that shows the signature and photo of the person who completed the form or declaration, such as a passport or driver's licence AND adoption papers or other court documents if applicable.

Dependents above 18 years of age

> Proof of financial dependency

Required Original



Provide evidence that all the dependents aged 18 years or older are financial dependent on you. Evidence may include bank statements, money transfers and rent receipts. If the child is aged 23 or is likely to turn 23 while your application is being processed, you must also provide a report from a qualified medical practitioner that states they are dependent on you or your partner due to the total or partial loss of their bodily or mental functions
