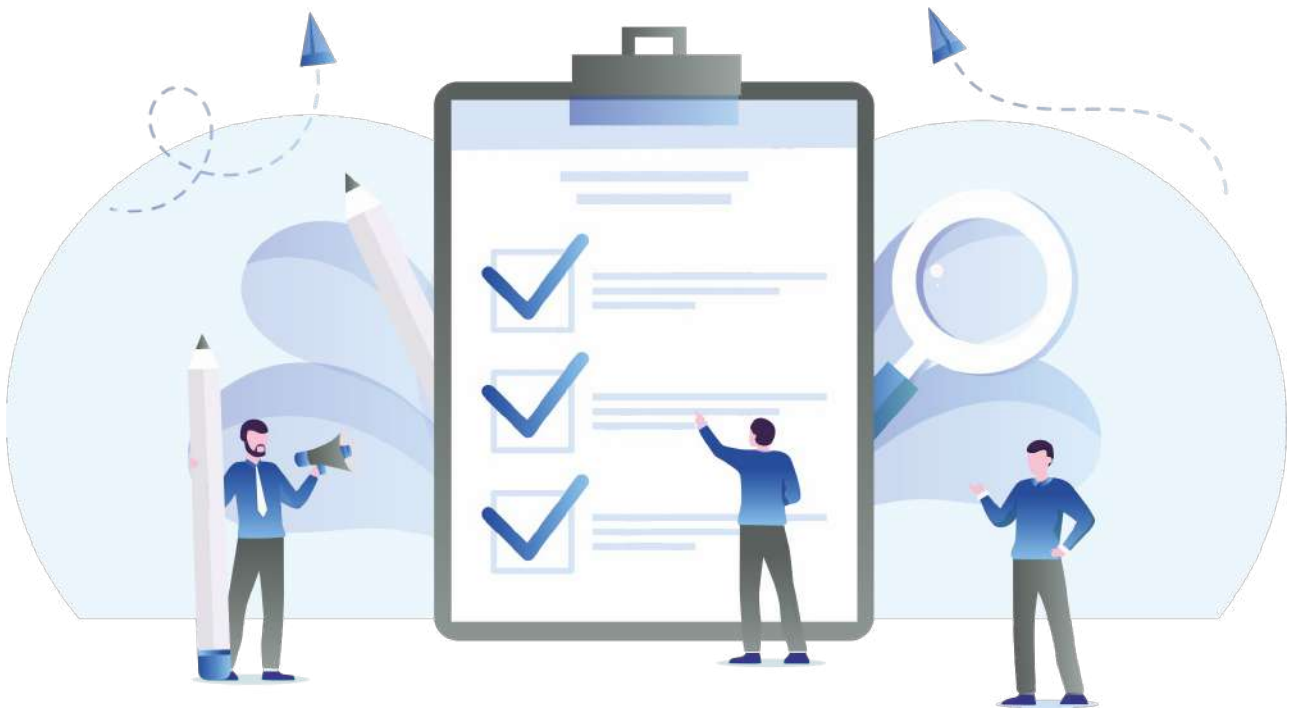

Other Documents

> **Passport**

 Required  Original

Passport all pages also add the previous passport (if applicable)

> **National Identity Document**

 Required  Original

A national identity card is required

> **Marriage Certificate or Deed Poll Certificate (Proof of change of name)**

 Required  Original

Documents that prove a change of name include: 1) A marriage or divorce certificate 2) Change of name documents from an Australian Registry of Births, Deaths and Marriages, or the relevant overseas authority 3) Deed Poll Certificate documents that show other names you have been known by

> **COE**

 Required  Original

Proof you have enough money for your stay and to leave Australia, such as: 1) Personal Bank Statements 2) Pay Slips 3) Audited Accounts 4) Tax Records 5) Credit Card Limit 6) Proof you own property or other assets in your home country.

> **Reason to Return Home**

 Required  Original

Reasons to return home can be proved by providing following reasons: 1) A letter from your employer stating they expect you to return to your job 2) Proof you are enrolled at a school, college or university in your home country 3) Proof you have close family members in your home country

> **Invitation Letter**

 Required  Original

A letter from your relative or friend in Australia, inviting you to visit. The letter could state: 1) Their relationship to you 2) The purpose of your visit and length of stay 3) If you will be staying with them. If this person will be paying for your stay, provide proof of their funds

> **Undertaking declaration [Form 1257]**

 Recommend  Original

If the applicant is not staying with a relative or legal guardian, provide Form 1257 Undertaking declaration. The person they are staying with must sign the form.

> **Parental Consent Form [Form 1229]**

 Recommend  Original

If you have a child under the age of 18 included in the visa application and one or both parents (or legal guardians) are not applying for an Australian visa, both parents will need to complete and sign the Form 1229 - Consent form to grant an Australian visa to a child under the age of 18 years. If you have sole custody of the child/ren, provide evidence such as a court order are required.

> Health Insurance for Overseas Visitor

 Recommend  Original

Health insurance is highly recommended to cover any unforeseen medical treatment you might need in Australia. As you are personally liable for all your healthcare costs while you are in Australia. Insurance can help limit your financial liability.

> Curriculum Vitae or Resume

 Recommend  Original

Your curriculum vitae or résumé should include full employment and educational history, including dates and positions held.
